Oral Exposure
If swallowed, wash out mouth with water provided person is conscious. Call a physician.

Inhalation Exposure
If inhaled, remove to fresh air. If breathing becomes difficult, call a physician.

Explosion Hazards
Azide reacts with many heavy metals such as lead, copper, mercury, silver, gold to form explosive compounds. Copper and lead azides are more sensitive than nitroglycerine. Azide reacts with metal halides to give a range of metal azide halides, many of which are explosive. Incompatible with chromyl chloride, hydrazine, bromine, carbon disulfide, dimethyl sulfate, dibromomalonitrile.

Laboratory experiments in animals have shown sodium azide to produce a profound hypotensive effect, demyelination of myelinated nerve fibers in the central nervous system, testicular damage, blindness, attacks of rigidity, and hepatic and cerebral effects. Prolonged exposure can cause: Nausea, headache, and vomiting. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
