Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: light yellow clear liquid. Flash Point: 73 deg C.

Caution! Combustible liquid and vapor. May cause respiratory and digestive tract irritation. May cause eye and skin irritation. May cause central nervous system depression. The toxicological properties of this material have not been fully investigated.

Target Organs: Central nervous system.

Potential Health Effects

Eye: May cause eye irritation. May cause chemical conjunctivitis and corneal damage.

Skin: May cause irritation and dermatitis. May cause cyanosis of the extremities.

Ingestion: May cause gastrointestinal irritation with nausea, vomiting and diarrhea. The toxicological properties of this substance have not been fully investigated.

Inhalation: May cause respiratory tract irritation. The toxicological properties of this substance have not been fully investigated. Aspiration may lead to pulmonary edema. Inhalation at high concentrations may cause CNS depression and asphyxiation.

Chronic: Prolonged or repeated exposure may cause nausea, dizziness, and headache. Effects may be delayed.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

Ingestion: Do not induce vomiting. Get medical aid. Wash mouth out with water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-

mouth resuscitation.

Section 5 - Fire Fighting Measures

General Information: As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. Handling: Wash thoroughly after handling. Use only in a well-ventilated area. Avoid breathing dust, mist, or vapor. Avoid contact with skin and eyes. Empty containers retain product residue, (liquid and/or vapor), and can be dangerous. Keep container tightly closed. Keep away from heat, sparks and flame. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames.

Storage: Keep away from heat, sparks, and flame. Store in a tightly closed container. Store in a cool, dry, well-ventilated area away from incompatible substances.
