Sodium azide/ hydrazoic acid causes a profound lowering of blood pressure and inhibits cellular respiration. Laboratory experiments in animals have shown sodium azide to produce a profound hypotensive effect, demyelination of myelinated nerve fibers in the central nervous system, testicular damage, blindness, attacks of rigidity, and hepatic and cerebral effects. Prolonged or repeated exposure can cause: Nausea, Dizziness. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
